10.1.7 GRAND FINAL ENTRANCE FEES

10.2 FINES

10.2.1 CLUB

- (1) Failure to submit a competitive team result. \$35
- (2) Late submission of a competitive team result. \$35
- (3) Competitive team sheet incorrectly filled out. \$25
- (4) Failure by a Club to remove player from a team sheet when they did not participate in the game. Note: this fine is per player. \$25
- (5) Competitive team conceding a walk over. The fine to be collected by the Association and paid to the other Club.
- All forfeits including more than 48 hours' notice will incur a fine \$200
- Advised between 48 hours and 24 hours in writing \$400
- 24 hours or less or No Notice \$750
- (6) Competitive team withdrawal after compilation of fixture \$250
- (7) Fielding an ineligible player \$120
- (8) Fielding a suspended player \$500
- (9) Fielding an unregistered player \$250
- (10) Fielding an over age player \$150
- (11) Failure to notify the respective Coordinator or B&DSA \$100
- Secretary of any change to venue or time for a game
- (12) Failure to submit referee's best and fairest votes within 10 day of a competitive game. Note: this fine is per game. \$10
- (13) Ground not marked before the scheduled kick-off time for the first game on that particular ground. \$65
- (14) Failure to provide ground officials. \$65
- (15) Spectator boundary not clearly marked for competitive games. \$65
- (16) Non-attendance at compulsory B&DSA meeting. \$120

(17) Member clubs may write to the Association asking for a stay of any fine imposed on their Club. All correspondence should convey any extenuating circumstances. This MUST be done within fourteen (14) days of date given on the invoice as correspondence received after that period will not be accepted and the fine will stand

10.2.2 PLAYERS

10.2.2.1 Red Card Offences

- (1) First Offence in current season. \$80
- (2) Second and each subsequent red card offence in current season. \$100



10.2.2.2 Yellow Card Offences

- (1) First five (5) yellow card offences in current season. \$40
- (2) Second and each subsequent cumulative yellow card offences \$60
in current season.

10.2.3 REFEREES

- (1) Paperwork not submitted within 3 working days of match. \$20
- (2) Referee payments will not be made until all match paper work has been submitted.

10.3 PAYMENT

10.3.1 DUE DATE

- (1) The due date for all invoices is 30 days after date of issue on the invoice.

10.3.2 LATE PAYMENT PENALTY

- (1) A late payment penalty of 5% will be applied to all outstanding amounts after the due date and included on the Club’s next invoice.
- (2) An additional late payment penalty of 5% will be applied to all outstanding amounts for each and every additional 30 days the account is outstanding after the due date. This charged will be included on the Club’s next invoice.

10.4 OUTSTANDING FEES TO CLUB

- (1) Any player who owes affiliation fees to a BDSA member club, shall not be permitted to play with another BDSA member club, until owed affiliation fees are paid.
