3.1 BY-LAW 2006-1 –PENALTY FOR OUTSTANDING DEBTS

- 1) The Board have the right and discretion to deduct premiership points from a Club's team or teams entered in the Senior or Reserve competition, if the Club has not taken any substantive action to settle a debt owed to the Association for greater than 90 days.

3.1.1 APPROVED

- 1) Approved at the Board meeting of the 13 June 2006.

3.1.2 PROCEDURE

- 1) The following procedure must be followed for the implementation of this By-Law.
 - A) The Treasurer must prepare a written report why the Board should exercise its powers under By-Law 2006-1. The report must contain a summary of the contents of all relevant correspondence and dates on which the correspondence was received or sent.
 - B) The Treasurer will move that the Board adopt the report.
 - C) If the Board adopts the report, the report will be sent to the Club informing them that the Board is considering exercising its powers under By-Law 2006-1.
 - D) At a Board meeting following the adoption of the report, the Treasurer can move a motion to deduct a fixed number of points from the Club's team or teams in the Senior or Reserves competition. The motion must contain a date, at least 2 weeks after the meeting, by which the Club can pay all outstanding amounts to ensure that the points are not deducted.
 - E) If payment has not been received by the date specified in the motion to deduct the points, the points will be deducted after the next round of competition.

3.1.3 APPEAL

- 1) The Club can appeal the Board decision under the *Disciplinary Code* Section 4.



3.2 BY-LAW 2007-1 –BOARD MEMBERS ELECTION YEAR

- 1) Clause 13.2 of the Association Rules requires that 6 Board members be elected at each AGM after 2000 and Clause 13.1 states that Board members term of office will be 2 years.
- 2) This by-law records which positions will be up for election in odd and even years.
- 3) Odd years are 2007, 2009 etc., and even years are 2008, 2010 etc.
- 4) Positions up for election in odd years:
 - A) Vice-President.
 - B) Secretary.
 - C) Registration Officer.
 - D) Publicity Officer.
 - E) Northern Co-ordinator.
 - F) General Member.
- 5) Positions up for election in even years:
 - A) President.
 - B) Treasurer.
 - C) Assistant Secretary.
 - D) Southern Coordinator.
 - E) Assistant Registration Officer.
 - F) General Member
